Heard Mr. AR Tahbildar, learned counsel appearing for the applicant.</li> <li>2. The grievance of the applicant is that despite direction issued vide order dated 26.08.2016 passed in OA-13 of 2016 directing the respondents to pay the disability element of the pension with rounding off benefit and arrear with interest, the said direction has not been implemented by the respondents.</li> <li>3. Having regard to the aforesaid contention of the applicant, we issue notice to the respondents. Since the respondents are represented by Brig N.Deka (Retd), learned CGSC assisted by Akash Vashishta, OIC Legal Cell, 51 Sub Area, no fresh notice needs to be issued.</li> </ol>

4. Brig N.Deka (Retd), learned CGSC on instruction has submitted that decision has been taken by the Records to move the Hon'ble Supreme Court against the aforesaid order dated 26.08.2016. Learned counsel, however, submits that he is not aware about the present position of the aforesaid decision.

5. Having regard to above and since the direction was passed as long back as on 26.08.2016, we direct the respondents either to produce the copy of order that may be passed by the Hon'ble Supreme Court or the compliance report, on the next date fixed.
