Heard Mr. Akhilesh Lal, learned Counsel for the applicant.

2. The applicant in O.A. 05/2014 has filed this C.A.-07/2016 alleging non-compliance of the directions contained in the order dated 10.02.2016 passed in O.A. 05/2014.
3. Learned Counsel appearing for the respondents producing a copy of the PPO No. S/0032/2017 dated 20<sup>th</sup> April, 2017 has submitted that the directions contained in the order has been complied with.
4. Learned Counsel appearing for the applicant in the C.A. submitted that as per his instruction the monetary benefit in terms of the PPO has not yet been credited in the applicant's account. It has also been submitted that the costs awarded vide order dated 15.12.2016 has not been paid.
5. Having regard to the aforesaid PPO, copy of which is placed on record, we close and dispose of the C.A. giving liberty to the applicant to approach this Tribunal again by means of another M.A., if the benefit of the PPO is not received within a period of 2 (two) months from today.
6. The respondents shall also pay the costs awarded to the applicant vide order dated 15.12.2016 passed in the present C.A. within the aforesaid period of two months from today, failing which it is also open to the applicant to approach this Tribunal by means of another M.A.
7. C.A. accordingly stands closed and disposed of.
