	Heard Mr. Diganta Gogoi, learned Counsel for the applicant and Mr. N.Baruah, learned Central Govt. Standing Counsel appearing for the respondent Nos. 1 to 5 and Mr. A.H.Mullah, learned Counsel appearing for the respondent No. 6.
	2. Learned Counsel for the applicant and the learned Counsel appearing for the respondent No. 6 have submitted that despite the order dated 19 th July, 2016 passed by this Tribunal, the agreed amount of Rs. 5,00,000/- (Five Lakhs) to be paid by the respondent No. 6 to the applicant could not be paid as no retiral benefit pursuant to the PPO issued has been released by the respondent Nos. 1 to 5 to the respondent No. 6.
	3. Learned Counsel appearing for the respondent No. 6 has submitted that as soon as the said amount is paid to him in his bank account by the respondent Nos. 1 to 5, within one week therefrom the amount of Rs. 5,00,000/- (Five lakhs) would be transferred to the account of the applicant in terms of the settlement arrived at between the applicant and the respondent No. 6.

- 4. Learned Counsel appearing for the respondent Nos. 1 to 5 submitted that a direction may be issued to release whatever retiral benefit payable to the respondent No. 6.
- 5. Having regard to the various orders passed by this Tribunal and also the submissions advanced by the learned Counsel for the parties, we issue the following directions:
 - (i) The respondent Nos. 1 to 5 shall ensure credit of the amount due and payable pursuant to the PPO already issued to the account of the respondent No. 6 within three weeks from now.
 - (ii) The respondent Nos. 1 to 5, however, shall not release the commuted amount of pension until further orders from this Tribunal.
 - (iii) The respondent Nos. 1 to 5 shall obtain necessary information from the Bank, if any amount has already been credited to the respondent No. 6 pursuant to the PPO issued.
 - (iv) The respondent No. 6 within a week from the date of credit of the aforesaid amount in his account shall transfer an amount of Rs. 5,00,000/- (Five Lakhs) to the account of the applicant.
 - (v) The respondent No. 6 on the next date fixed shall produce proof of payment of the aforesaid amount to the applicant.
