Heard Mr. A.R.Tahbildar, learned Counsel appearing for the applicant and Mr.Pranjal Sarma, learned Counsel, assisted by Capt. Akash Vashishta, OIC, AFT, Legal Cell, Guwahati, appearing for the respondents.</p> <p>2. This is a case wherein the applicant was invalidated out of service and is getting only meagre amount of Rs.702/- (Rupees Seven Hundred Two) per month, although his disability has been assessed at 20 % for life and attributable to Military Service. At Annexure 'E" of the Original Application, PCDA (P) on 11.05.2016 asked The Officer-in Charge, Assam Regiment for re-assessment of medical board although the subject matter indicates reassessment medical board of the applicant. The content of the letter states " if individual is eligible than take necessary action at your end otherwise furnish a suitable reply to all concerned under intimation to this office." The Vice</p>

President, ESM Association of Arunachal Pradesh on 14.06.2017 has reminded the authorities to calculate the amount correctly. No reply has been received as yet by the applicant from the OIC Records. This lackadaisical approach on the part of the OIC, Records, even after a period of almost three years, is deplorable.

3. Learned Counsel for the applicant submits another letter wherein the applicant was asked to forward some documents to Records. Assam Regiment letter on 22.08.2017 which he has submitted. Therefore, it surprises us and that no action has been taken by the OIC Records in correctly recalculating the amounts due to the applicant.

4. As the Counter Affidavit has not yet been filed, we direct the OIC Records or representative authorized by him to appear before this Bench on the next date of hearing with the complete calculation sheet, indicating both disability element and service element for the period in which he was invalidated out, duly authenticated by the OIC Records.

5. List the matter whenever the Division Bench reassembles next.
