**ORDER**

*(Per B.P.Katakey, Officiating Chairperson)*

Heard Mrs. Rita Devi, learned counsel appearing for the applicant and Brig N.Deka (Retd.), learned CGSC assisted by Col Anand, OIC, AFT Legal cell appearing for the respondents.

(2) Having heard the learned Counsel for the parties and upon perusal of the averments made in the application, we are of the considered opinion that since the applicant has not filed any appeal (s) against the decision(s) dated 05.05.1987 (Ann-B to the OA), the OA needs to be disposed of allowing the applicant to prefer appeal(s) before the appropriate authority.

(3) Ordered accordingly.

(4) In case, such appeal (s) is filed within a period of 3 months from the date of filing of the appeal, the appellate authority shall consider the same on merit and shall not reject the same on the ground of limitation.

(5) Needless to say that the appellate authority shall pass a reasoned order on such appeal to be filed by the applicant. The order that may be passed shall be served on the applicant so as to enable him to approach the appropriate forum, if he has still any grievance.

(6) The OA accordingly stands disposed of.
