	<p><b><u>CORAM</u></b></p> <p>Hon'ble Mr. Justice Umesh Chandra Srivastava, Member(J) Hon'ble Air Mshl Balakrishnan Suresh, Member (A)</p> <p><b><u>ORDER</u></b></p> <p><b><u>03.04.2023</u></b></p> <p>Heard Shri R.K. Singh, Ld. Counsel for the applicants and Shri P.J. Barman, Ld. Counsel for the respondents.</p> <p>This Original Application has been filed for issuing direction to the respondents to reinstate the applicant in service after quashing the termination/dismissal order based on fraudulent enrolment.</p> <p>It is submitted by the Ld. Counsel for the applicants that applicant is not a case fraudulent enrolment. It is a case of genuine enrolment.</p> <p>There being delay in filing the Original Application, a delay condonation application has been filed separately and it is submitted that delay is not deliberate. As a matter of fact the applicant had approached the District Court for the redressal of his grievance by filing a Title Suit for Domicile Certificate as authentic and genuine which was later dismissed as withdrawn on the ground that it was wrongly filed in that Court.</p> <p>Ld. Counsel respondents has vehemently opposed the prayer.</p> <p>We have gone through the order dated 27.07.2022 of the District Judge, East Sessions Division, Teju, Lohit District, Arunanchal Pradesh and we find that applicants had earlier filed a case in the Court of District Judge which was later withdrawn on 27.07.2022.</p> <p>In view of the above, delay in filing the Original Applicant is not deliberate and is, therefore, <b>condoned</b>. Delay condonation application stands disposed off.</p>

**M.A. No. 25 of 2022**

For the reasons stated in affidavit filed in support of application, applicants are **allowed** to file Original Application jointly together. Misc. Application stands disposed off accordingly.

**OA No. 39 of 2022**
