This Original Application has been filed for issuing direction to the respondents to reinstate the applicant in service after quashing the termination/dismissal order based on fraudulent enrolment. It is submitted by the Ld. Counsel for the applicants that applicants are not a case fraudulent enrolment. It is a case of genuine enrolment.
